CHILDREN IN CONFLICT WITH THE LAW

- 1. A total of 29,768 crimes were alleged against children in the year 2020. In comparison, there has been a decline of 7.6% (32,235) in crimes alleged against children from 2019, and decline of 5.7% (31,591) from 2018.
- 2. All India rate of crimes alleged against children has decreased from 7.2% in 2019 to 6.7% in 2020. Amongst the States and Union Territories, Delhi has the highest crime rate (44.3%) with respect to crimes alleged against children.
- 3. The total number of children apprehended in 2020 is 35,352, compared to 38,685 in 2019, showing a decline of 8.6%.
- 4. For the purpose of comparative analysis, Table 1 shows the number of cases registered under various offences/crime heads in the last three years, viz., 2018-2020 with respect to children in conflict with the law.






6. From the total number of 35,352 children apprehended under both IPC+ SLL crimes in the year 2020, the number of boys is 34,958 and girls is 394.





10. With respect to disposal of children in conflict with the law apprehended and sent to courts, out of the total 74,124 children apprehended (number of children whose cases are pending disposal at the beginning of the year + children apprehended in 2020), CICL released as cases un-occurred/ quashed/ discharged by courts are 2,748;

- CICL sent home after advice or admonition are 16,482, CICL sent to Special Home or Fit Institute are 9,309.
- 11. In 2020, 2,157 CICL are dealt with fine, 526 are awarded imprisonment & 2,597 are acquitted or discharged. Whereas in 2019, 3,277 were dealt with fine, 658 were awarded imprisonment & 5,036 were acquitted or discharged.
- 12. 91.6% of juveniles were held guilty in 2020 as against 86.8% in 2019.
- 13. In 2020, 40,305 cases against CICL are pending disposal as against 39,156 pending in 2019. Between 2019 and 2020, pendency has increased by 2.9%.
